# **Proposed 2020 CHN Incentive Distribution Framework Updates**

#### Recap of Agreed Upon 2020 Incentive Model Proposed Updates

- Addition of SDoH Screening Measure
  - Allocate 25% (15 Points) of Clinical Quality Performance Category to SDoH Screening
  - o Ability to Earn Partial SDoH Screening Incentive Points Using Graduated Scale
- HPV Immunization Measure Removed (Included in Age 13 Imms. Measure)
- **BMI Percentile Measure Removed**
- Update Clinical Quality Targets Using Same Methodology as 2019 (Lower of NCQA 75th Percentile OR 2019 Blue KC Goal)
- Risk Adjusted Avoidable ED Visits / 1000 [Non-Emergent]
- Risk Adjusted Admissions / 1000 as Network-Level Measure
