Quality Improvement Insights and Learnings – Learn How Your Practice Can Improve!

Which Measures Does My Practice Need to Improve?! Click to view your practice's Rolling Year Blue KC quality performance results published in May 2018 for measurement period April '17 to March '18.

Chlamydia Screening - Key Learnings & Insights

- Review & share the measure definition with providers in your practice (see Chlamydia Screening Overview Slide Deck).
- Denominator for measure is relatively small. Low denominator enables improvement in the short term.
- Identify and flag patients identified as being potentially sexually active and qualifying for the measure (see Vision Patient Outreach Training Guide). Perform outreach based on patients' need of an annual well visit.
- Sexual activity trigger may be unknown to PCP (e.g. Ob-Gyn contraceptive diagnoses or scripts). Consider messaging Ob-Gyn to help complete the screening.
- Consider ordering just the chlamydia test rather than the combined chlamydia/gonorrhea test.

Asthma Medication Management (≥ 75% Controller Days Supply Coverage) - Key Learnings & Insights

- Review & share the measure definition with providers in your practice (see Asthma Measure Overview Slide Deck).
- Number of patients eligible for the measure is small. Identify qualifying asthma patients using Vision patient outreach (see Vision Patient Outreach Training Guide) to schedule routine asthma visits.
- Limit available refills for asthma controllers & relievers. Patients typically included in measure when prescribed 4 or more asthma pharmacy scripts in each of last 2 years.
- Sample controller medications are not included 75% days supply compliance is based exclusively on pharmacy claims.

Ensure your risk score is accurate by coding all diagnoses (at the appropriate acuity) managed during your clinic visits.


