New 2018 Blue KC ADHD Quality Incentive Measure – Understanding the Measure Definition

Blue KC introduced a new ADHD quality incentive measure for 2018. Click Here to learn more about the "Follow Up Care for Children Prescribed ADHD Medication" measure definition.

The measure evaluates whether a patient newly prescribed ADHD medication (i.e. no ADHD medication in the past 4 months) has at least 1 follow up visit with a prescribing provider within 30 days of the ADHD prescription.


