Social Determinants of Health (SDoH) Screening Measure Updates

The CMHN 2021 Incentive Model includes updates to the Social Determinants of Health (SDoH) Screening measure. Here is a key summary of those changes and updates:

- Denominator now includes all attributed members with at least 1 PCP office visit claim in calendar year 2021 (previously only included sick visits)
- Social Environment question added to minimum screening requirement. For examples of this requirement, [click here to view the CMHN Social Determinants of Health \(SDoH\) Screening FAQ](#).
- ICD-10 Z code is required for positive screenings
- Name of screening tool and the results of the screening must be documented in the EMR
- PCP visits conducted via telehealth will be included in the denominator
- SDoH screening can be completed via telehealth
 - Ensure the Place of Service (POS) Code 02 is included on the claim if completing the screening via telehealth!

Top Recommendations & Tactics to Inform Quality Improvement in 2021

Follow Up Care for Children Prescribed ADHD Medication

Initiation Phase (1 follow-up visit within first 30 days after initial Rx dispense date):

- Schedule both the initial ADHD visit and the 30-day follow up visit at the same time
- Schedule follow up visit within 30 days before family leaves the clinic

Continuation & Maintenance Phase (2 follow-up visits within 1-10 months after initial Rx dispense date):

- [Utilize CMHN ADHD Compliance Report](#) on the CMHN Portal to identify qualifying patients
- Require a follow up visit to continue ADHD medication

Appropriate Treatment for URI

- Nonsuppurative Otitis Media diagnoses are NOT competing diagnoses as these diagnoses do not warrant an antibiotic
- Ensure competing diagnoses are “linked” to a claim within 4 days of URI diagnosis
- If a strep test is to be performed on a patient, include a pharyngitis diagnosis along with a URI diagnosis. The presence of both diagnoses appropriately excludes the patient from the URI measure.

Well-Child Visits in the First 30 Months of Life

- Schedule the “By 1 Month Visit” the 3rd or 4th week of life to ensure 14 day minimum is exceeded
- Schedule the next recommended visit before the family leaves the office. If possible, schedule the next visit when the family arrives and is waiting in the waiting room. May consider scheduling multiple future preventive visits.
- [Utilize CMHN Portal Well Visit 15 Month Graduated Compliance Report](#) to identify patients in need of additional 0-15 month well visits

Child and Adolescent Annual Well-Care Visits (3-21 Years Old)

- Utilize InNote to identify well visit care gaps at the point of care
- Patient outreach using Innovaccer Worklists to target patients in need of well visit
- Schedule patients for annual well visit when patient checks out from sick visit

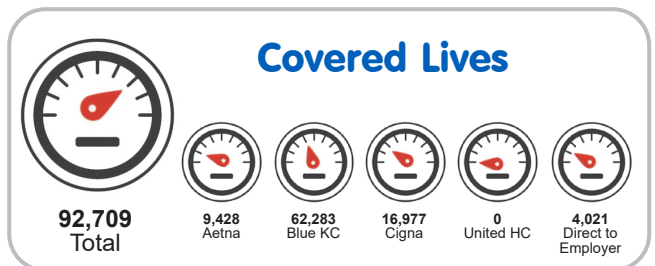
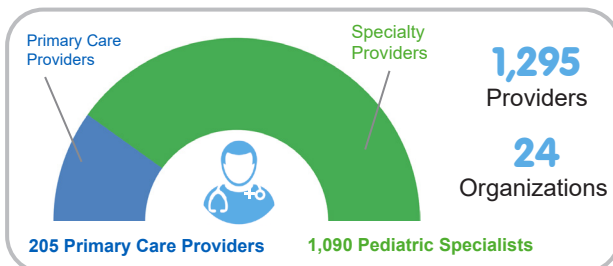
