Asthma Quality Improvement Strategies

- Asthma Visits 2+ Times Per Year: Clinical standard recommends at minimum a visit every 6 months (more frequently as clinically appropriate).² Use [Innovaccer Worklists](#) to target asthma patients in need of a 6-month visit.
- Comprehensive Asthma Visits: Include pre-visit planning, asthma control test, inhalation instruction, review of asthma action plan, assessment/education of environmental factors, asthma education, and evaluation of specialty referral.
- Provide and/or Review Inhalation Instruction at Every Asthma Visit (Service covered with CPT Code 94664). See [Asthma Inhalation Billing & Coding Guide](#) and [Inhalation Instructions for Clinical Practice \(CPT 94664\)](#).

Recommend using team-based care to perform (10-20 min initial visit; ~5-10 min for follow up visit)
